Hanwell Town FC acknowledges its responsibility to safeguard the welfare of every child and young person directly connected with the club and is committed to providing a safe environment for all. We recognise that those aged 16/17 years-of-age are legally defined as children and therefore we have a responsibility to ensure appropriate safeguards are in place. As such we subscribe to The Football Association's (The FA) Safeguarding Children Policy and Procedures.

Hanwell Town Football Club endorses and adopts the following key safeguarding principles:

• The child's welfare is, and must always be, the paramount consideration;

• All children and young people have a right to be protected from abuse regardless of their; age, gender, gender reassignment, sexual orientation, marital status or civil partnership, race, nationality, ethnic origin, colour, religion or belief, ability or disability, pregnancy and maternity;

• All suspicions and allegations of abuse will be taken seriously and responded to swiftly and appropriately; and

• Working in partnership with other organisations, children and young people and their parents/carers is essential. We acknowledge that every child or young person who plays or participates in football should be able to take part in an enjoyable and safe environment and be protected from poor practice and abuse.

Key Information for all staff and coaches regarding SAFEGUARDING

Safeguarding is everyone's responsibility within the club. Our welfare officers are Kevin Marron (Senior) and Michelle Malden (Youth).

What do I do?

- I refer all concerns to our welfare officers
- I do not (or promise to) keep anything secret
- I am clear about what safeguarding is and could be
- I am alert to signs/indicators of abuse
- I am aware that certain individuals are more at risk of abuse, including SEN and young people in care
- I am aware of those who are vulnerable

For coaches of females: I am aware I have a legal duty to report suspected or potential incidents of FGM to police.
